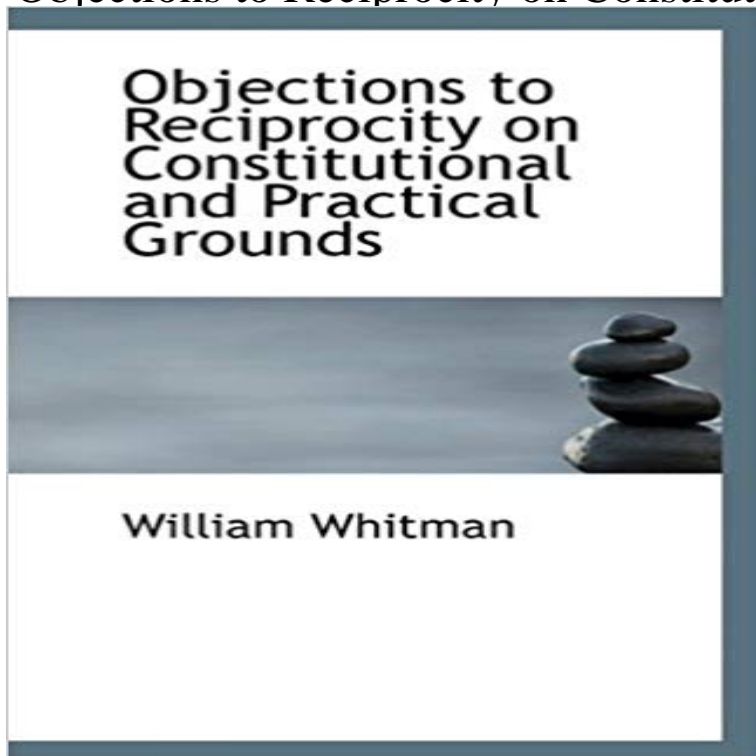


## Objections to Reciprocity on Constitutional and Practical Grounds
