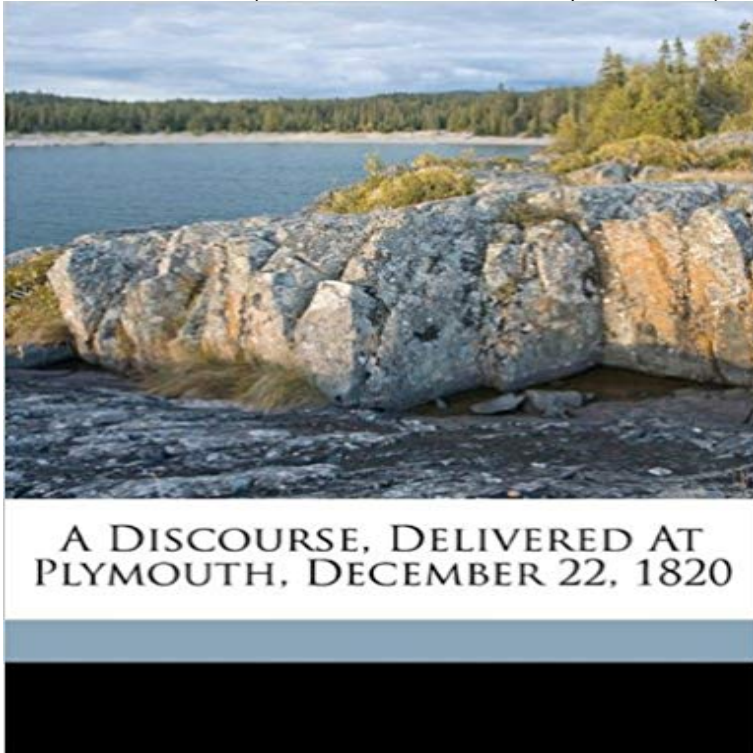


## A Discourse, Delivered at Plymouth, December 22, 1820
