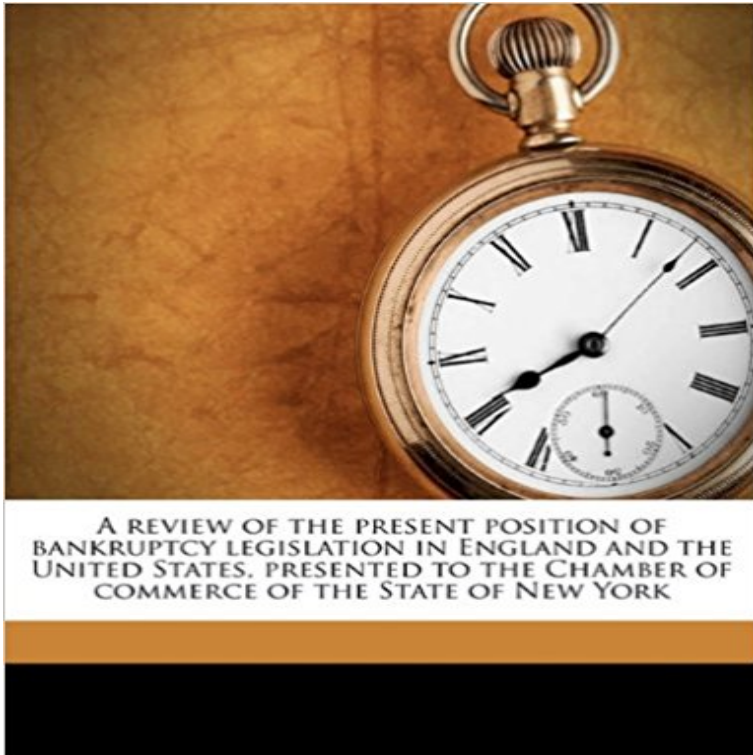


A review of the present position of bankruptcy legislation in England and the United States, presented to the Chamber of commerce of the State of New York
