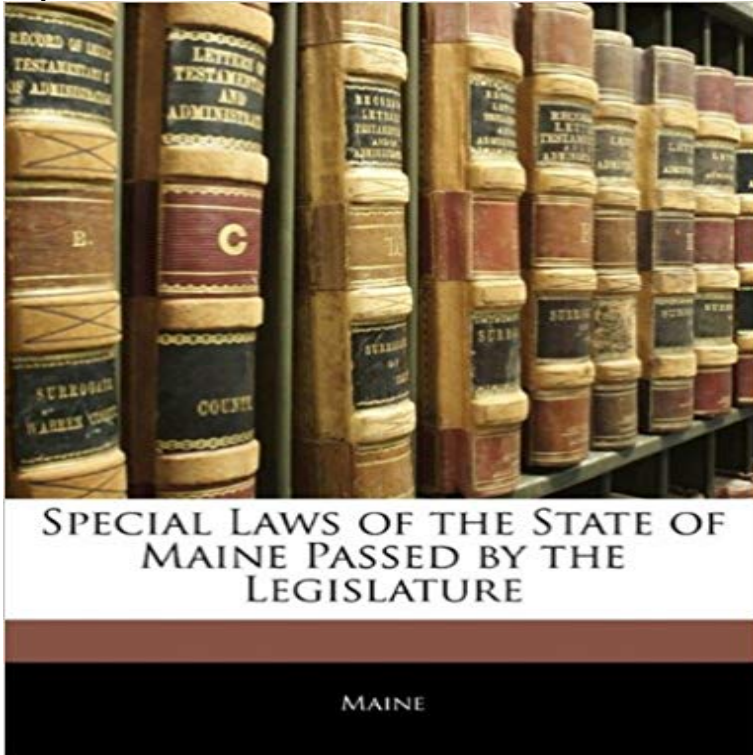


Special Laws of the State of Maine Passed by the Legislature
