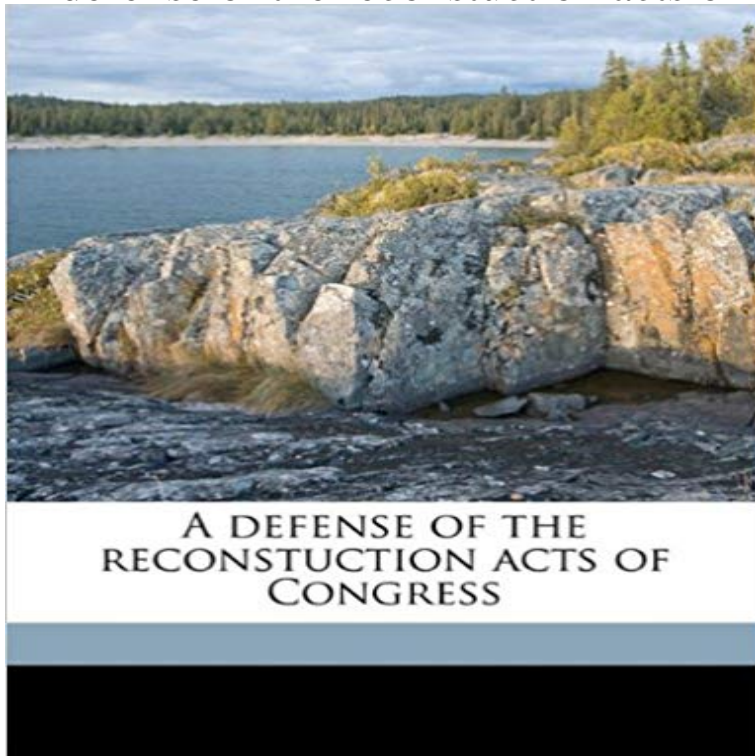


## A defense of the reconstruction acts of Congress
