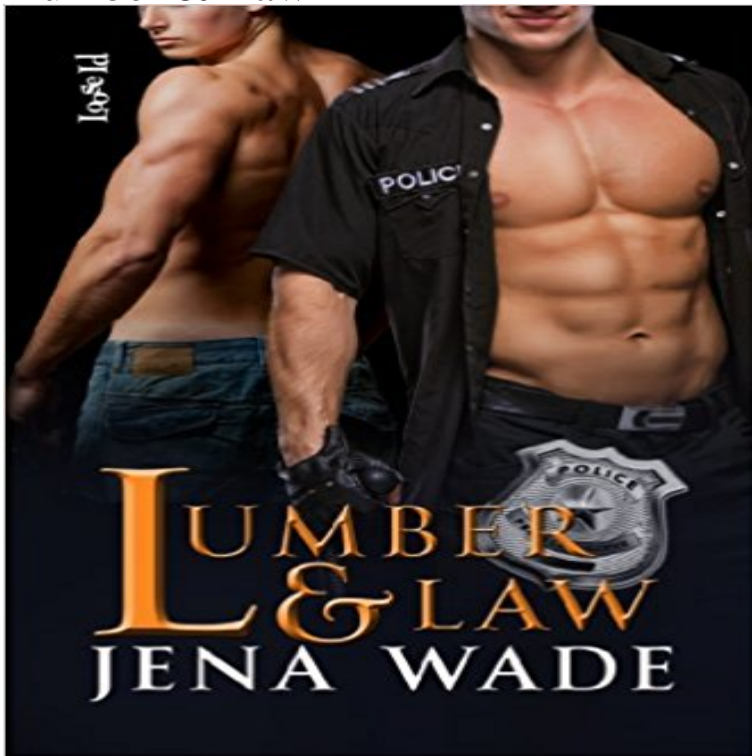


## Lumber & Law
