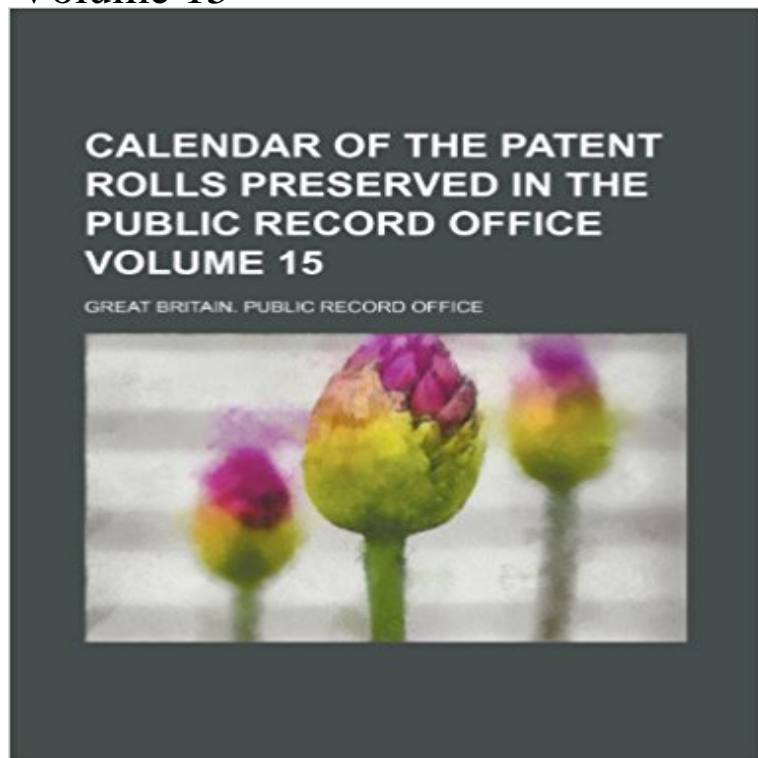

Guichard de Jo, a Cluniac monk, preferred to be prior thereof in the room of John Caprarii, resigned, by Peter abbot of Cluny, the king having taken his fealty and restored to him the temporalities. Mandate to the treasurer and barons of the Exchequer, that, after taking from him sufficient security that he will render at the Exchequer for the temporalities of the priory every year for so long as the causes for which alien religious houses are in the kings hands continue, the fixed amount which his predecessor paid, they shall cause the temporalities to be delivered to the said prior.
