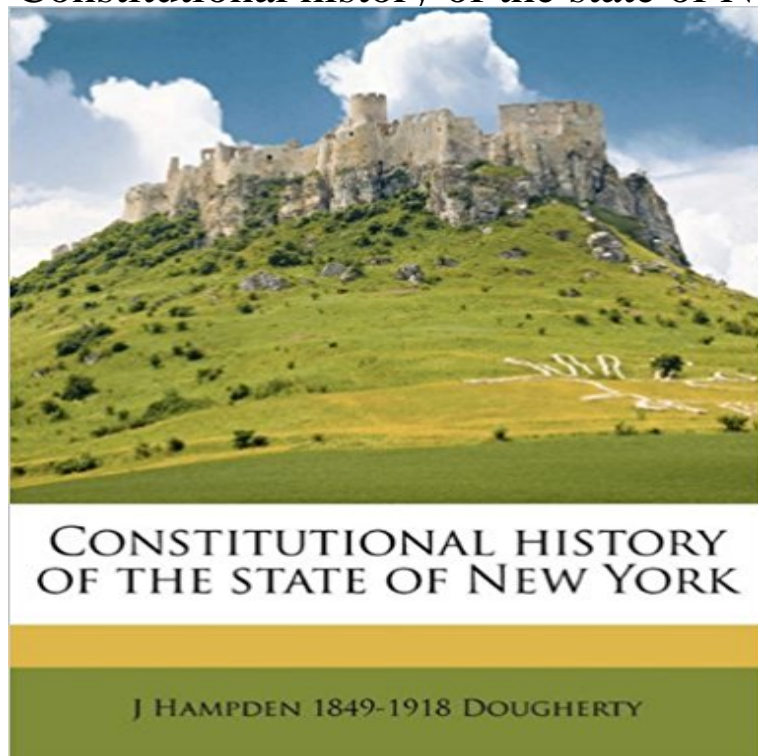


Constitutional history of the state of New York
