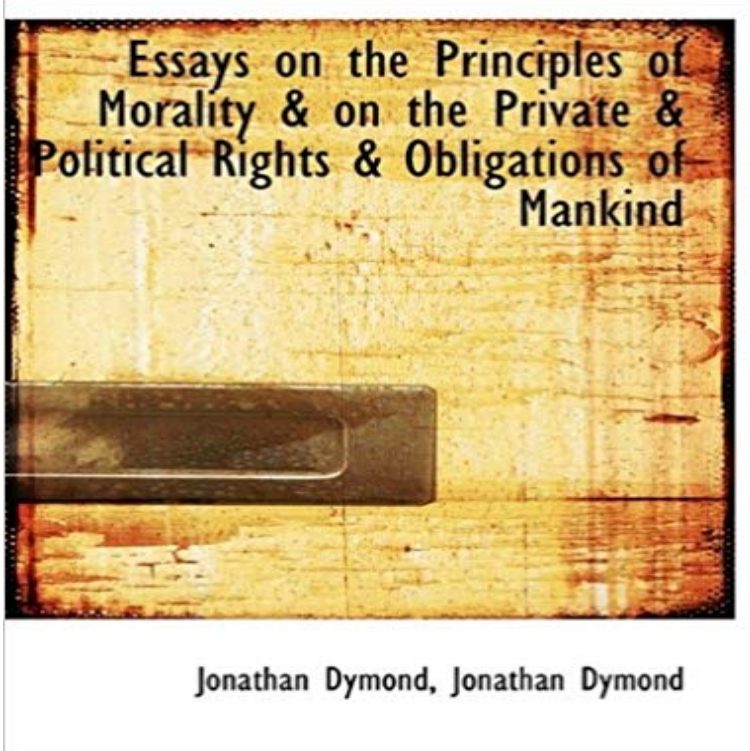


# Essays on the Principles of Morality & on the Private & Political Rights & Obligations of Mankind
