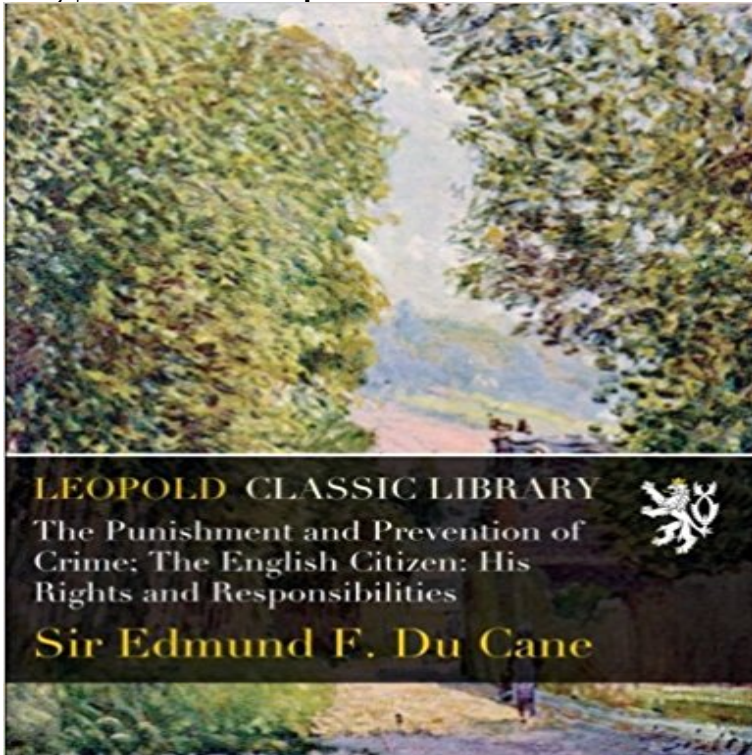


## The Punishment and Prevention of Crime; The English Citizen: His Rights and Responsibilities
