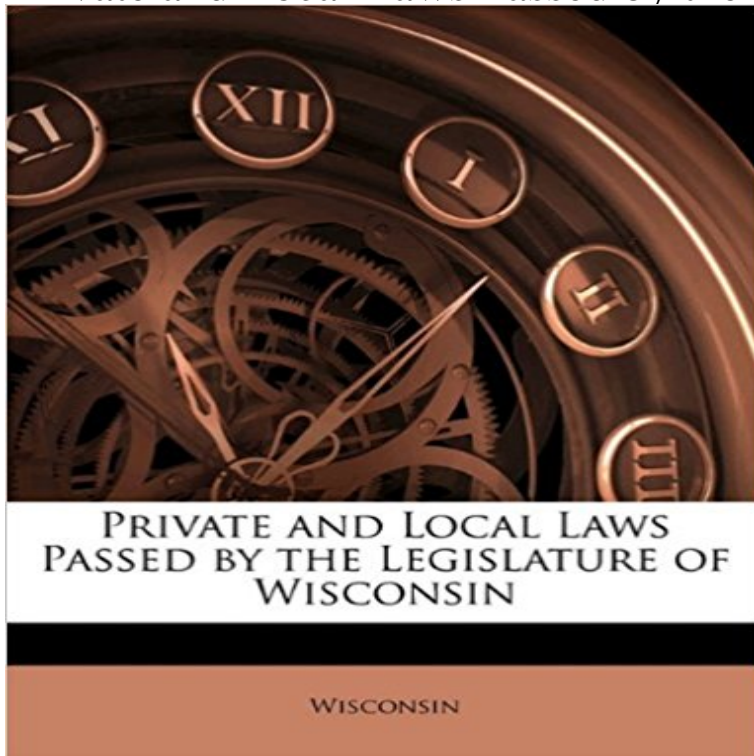


## Private and Local Laws Passed by the Legislature of Wisconsin
