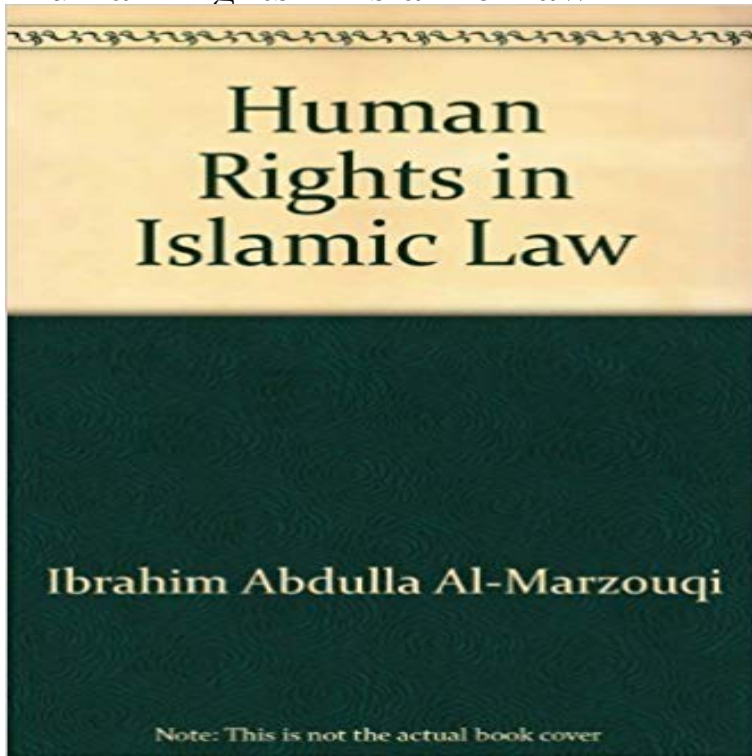


Human Rights in Islamic Law
