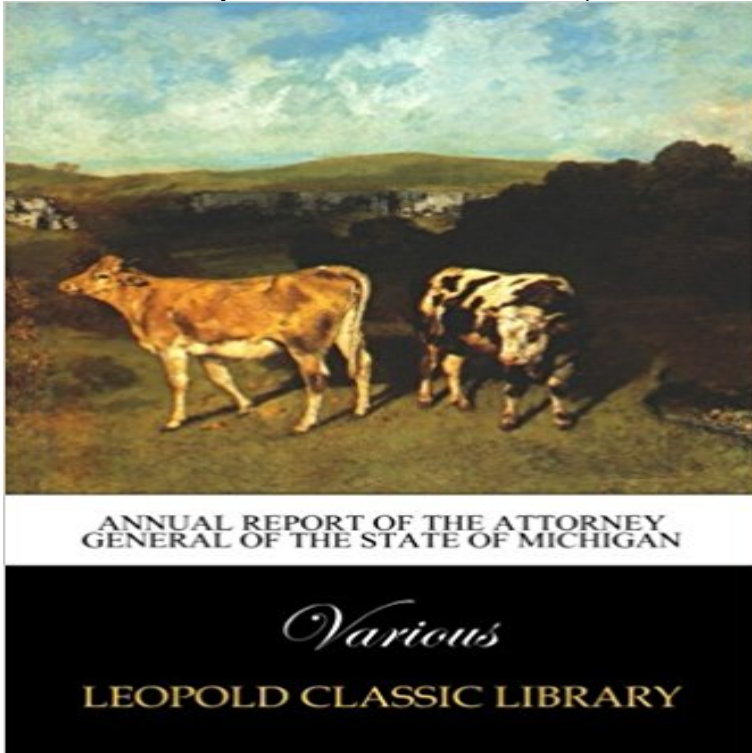


# Annual Report of the Attorney General of the State of Michigan
