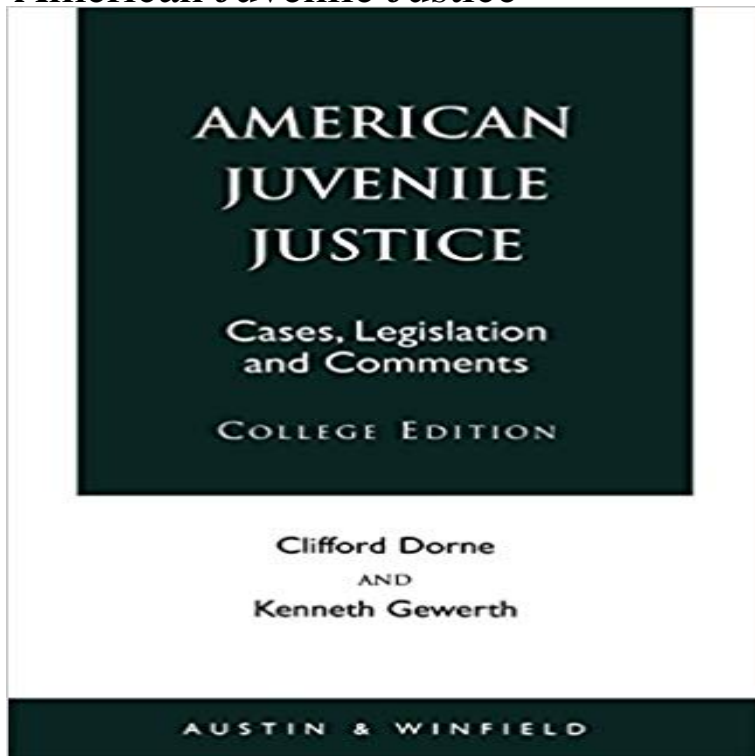


## American Juvenile Justice
