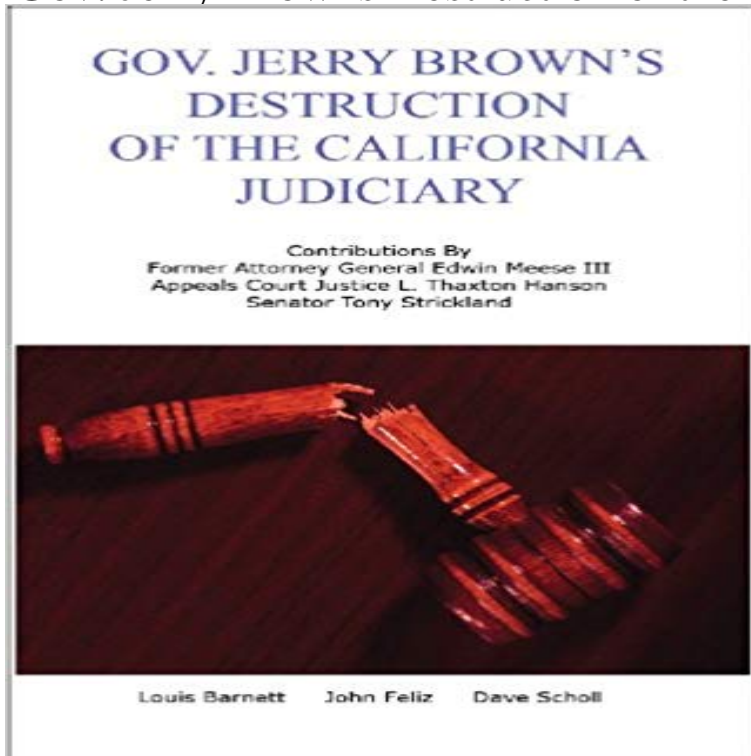


Gov. Jerry Browns Destruction of the California Judiciary
