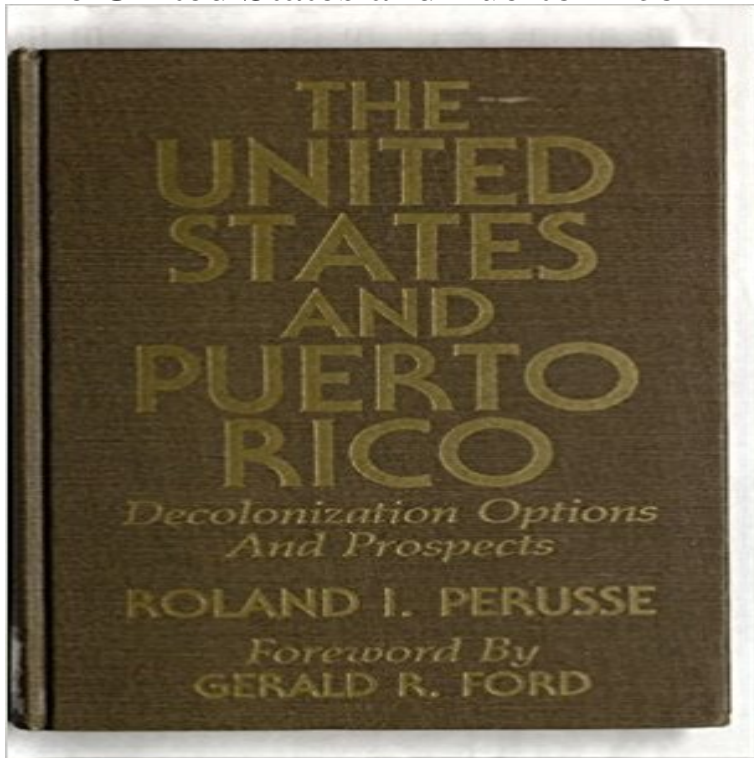


The United States and Puerto Rico
