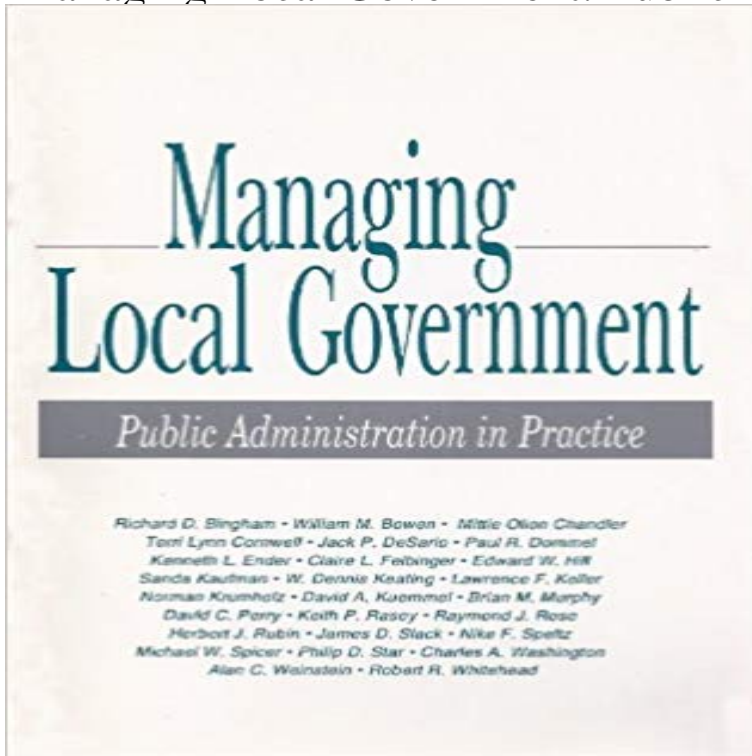


Managing Local Government: Public Administration in Practice
