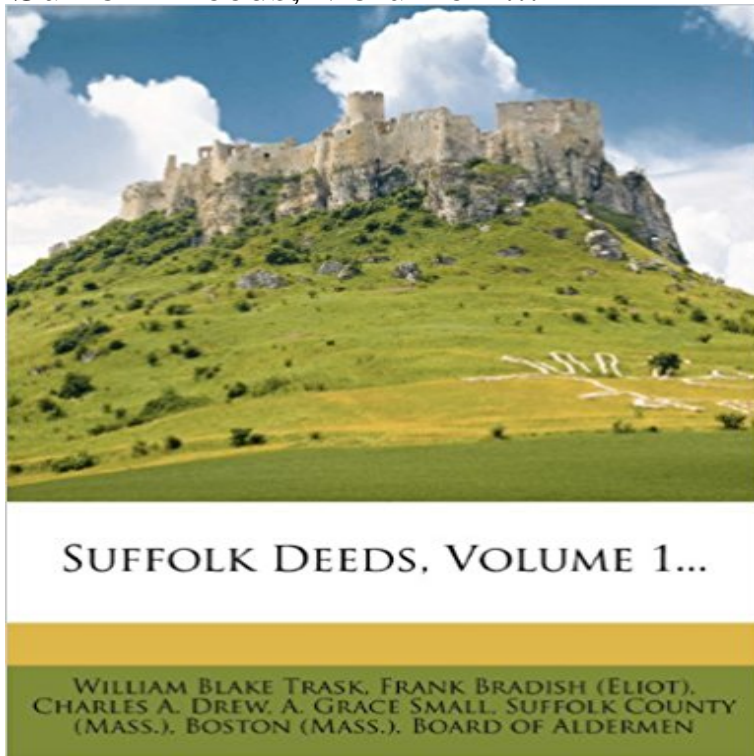


## Suffolk Deeds, Volume 1...
