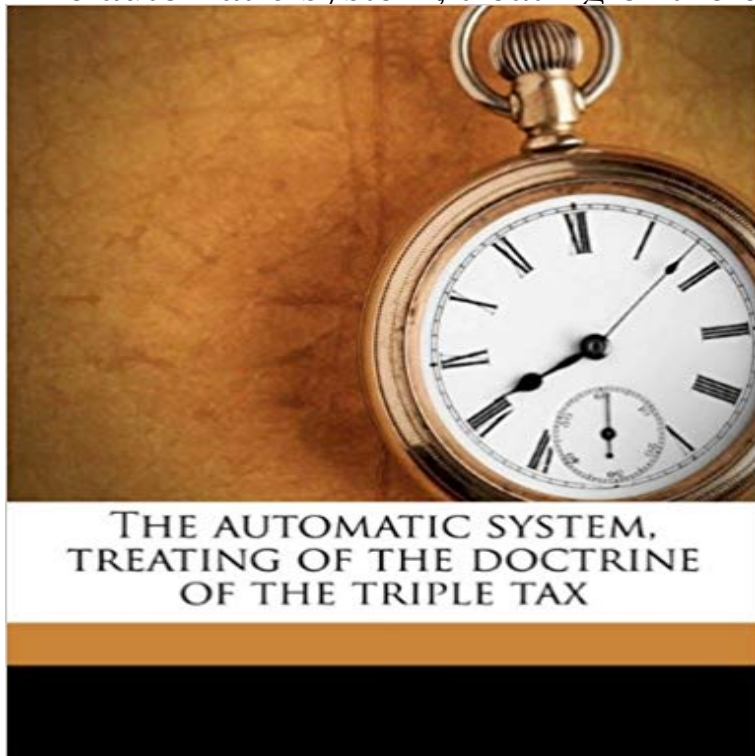


## The automatic system, treating of the doctrine of the triple tax
