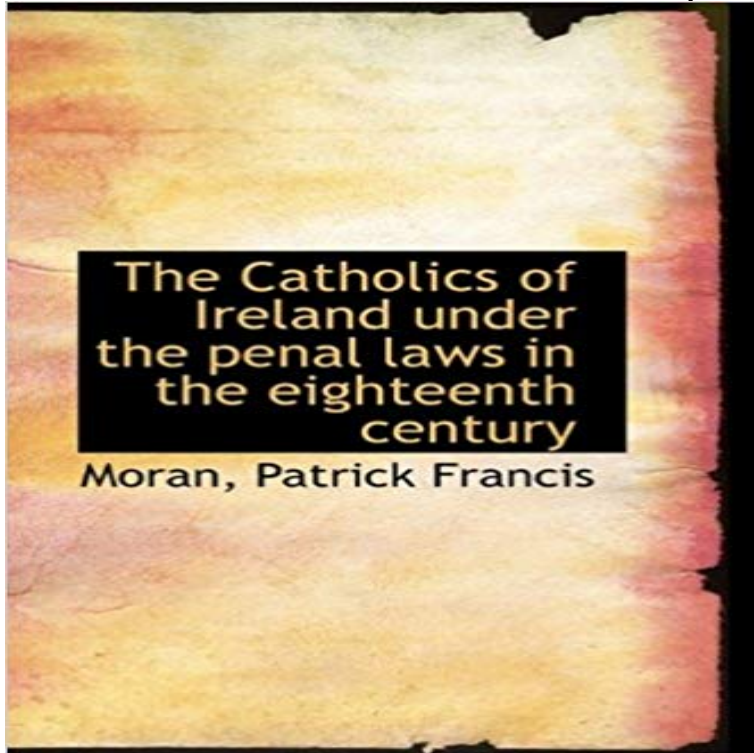


The Catholics of Ireland under the penal laws in the eighteenth century
