

The Legal Status of the Arabs in Israel (Westview Special Studies on the Middle East)



This study examines how the Israeli legal system copes with two major issues. The first is the tension between the constitutional definition of Israel as both a Jewish state and a democracy committed to equal rights for all its citizens. The second issue is the delicate position of a national minority in a state which, since its establishment, has been involved in a bitter conflict with the Palestine nation to which that minority belongs.
