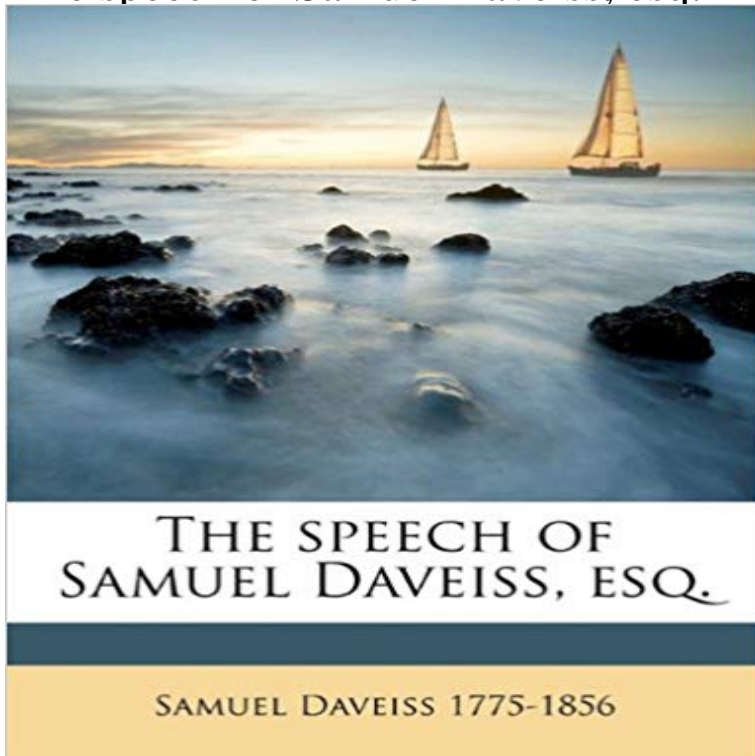


## The speech of Samuel Daveiss, esq.
