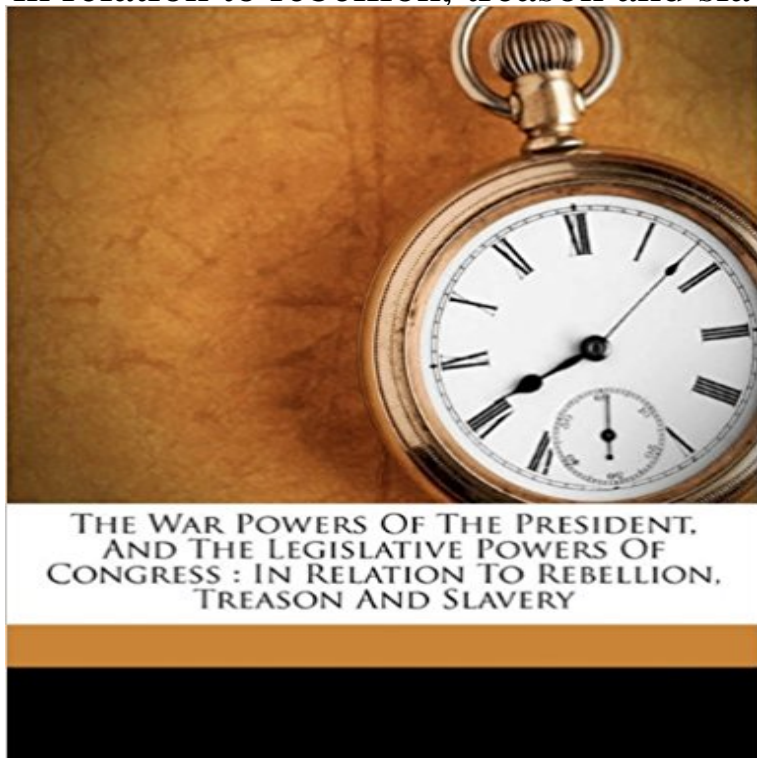


The war powers of the President, and the legislative powers of Congress: in relation to rebellion, treason and slavery
