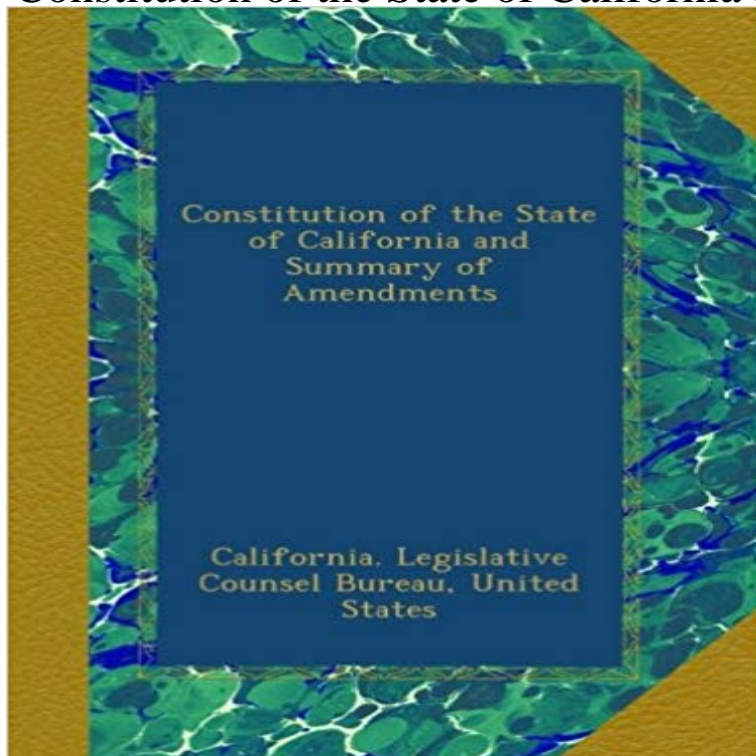


Constitution of the State of California and Summary of Amendments
