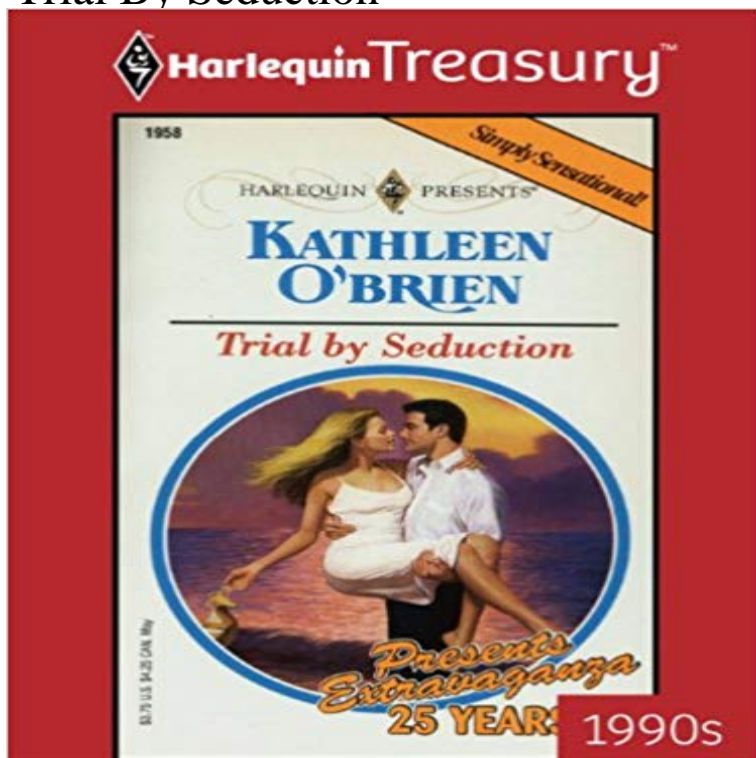


## Trial By Seduction
