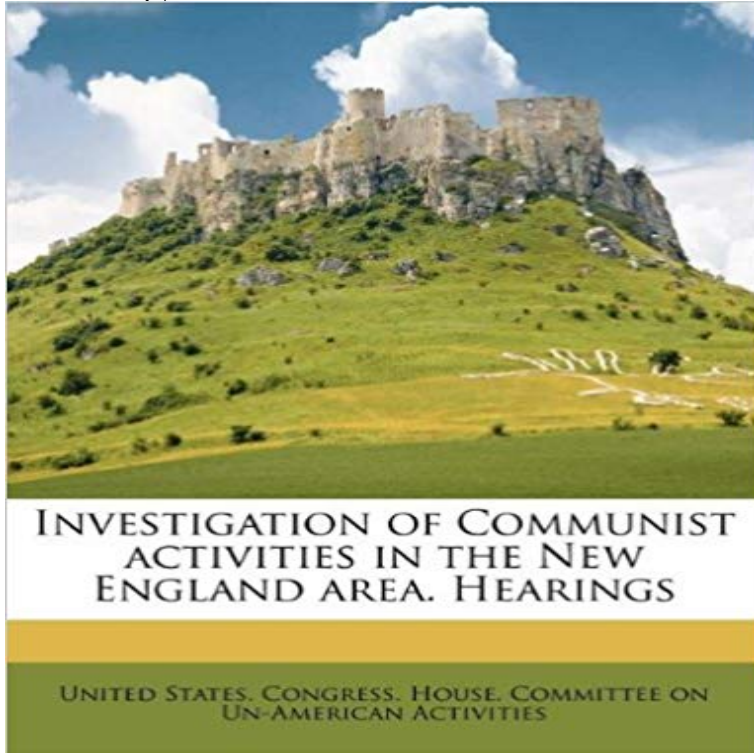


# Investigation of Communist activities in the New England area. Hearings
